# 7.0 INSTRUCTIONS FOR THE CORRECT USE OF THIS REFERENCE MATERIAL

#### 7.1 Storage and Handling Recommendations

- Store between approximately 4° - 30° C while in sealed TCT bag.

- While stored in the sealed TCT bag, transpiration of this CRM/RM is negligible. After opening the sealed TCT bag transpiration of the CRM/RM will occur, resulting in a gradual increase in the analyte concentration(s). It is the responsibility of the user to account for this effect. When the bottle is weighed both before and after being placed in storage, the mass difference observed will be a measure of transpiration mass loss.

- After opening the sealed TCT bag, keep cap tightly sealed when not in use and store between  $4^{\circ} - 24^{\circ}$  C to minimize the effects of transpiration. Use at  $20^{\circ} \pm 4^{\circ}$  C to minimize volumetric dilution error when using the reported density. Do not pipette from the container. Do not return removed aliquots to container.

Atomic Weight; Valence; Coordination Number; Chemical Form in Solution - 107.87 +1 6 Ag(H2O)6+ Chemical Compatibility -Stable in HNO3, and HF. Avoid basic media. Ag forms more insoluble salts than any other metal. It also is subject to photochemical reduction to the metal in HCl media although 10 µg/mL solutions in 10% HCl [AgClx1-x] are commonly used in the analytical laboratory. The most common solubility problems exist with arsenate, arsenite , bromide, chloride, iodide, carbonate , chromate, cyanide, iodate, oxalate, oxide, sulfate, sulfide, tartrate, and thiocyanate in aqueous media. The addition of nitric acid renders many of these salts soluble.

**Stability** - 2-100 ppb levels stable for 75+ days when mixed with equivalent levels of all other elements including the precious metals (where chloride is present) when in 1% HNO3 / LDPE container. 1-10,000 ppm solutions chemically stable for years in 1-5% HNO3 / LDPE container.

#### 11.3 Period of Validity
