3.0 CERTIFIED VALUES AND UNCERTAINTIES

4.0 TRACEABILITY TO NIST

The concentration of this solution standard has been verified by Inductively Coupled Plasma Spectroscopy (ICP) and is traceable to NIST SRM 3117a.

4.1 Thermometer Calibration

- All thermometers are NIST traceable through thermometers that are calibrated by an accredited calibration laboratory.

4.2 Balance Calibration

- All analytical balances are calibrated by an accredited calibration laboratory and procedure. The weights used for testing are annually compared to master weights and are traceable to NIST.

7.0 INSTRUCTIONS FOR THE CORRECT USE OF THIS REFERENCE MATERIAL

7.1 Storage and Handling Recommendations

- Store between approximately 4° 30° C while in sealed TCT bag.
- While stored in the sealed TCT bag, transpiration of this CRM/RM is negligible. After opening the sealed TCT bag transpiration of the CRM/RM will occur, resulting in a gradual increase in the analyte concentration(s). It is the responsibility of the user to account for this effect. When the bottle is weighed both before and after being placed in storage, the mass difference observed will be a measure of transpiration mass loss.
- After opening the sealed TCT bag, keep cap tightly sealed when not in use and store between 4° 24° C to minimize the effects of transpiration. Use at $20^{\circ} \pm 4^{\circ}$ C to minimize volumetric dilution error when using the reported density. Do not pipette from the container. Do not return removed aliquots to container.

Chemical Compatibility - Soluble in HCI, and HNO3. Avoid HF, H3PO4, H2SO4 and neutral to basic media. Stable with most metals and inorganic anions forming an insoluble carbonate, oxide, oxalate, and fluoride and sparingly soluble sulfates (La -Eu exhibit low sulfate solubility). Avoid mixing with elements / solutions containing moderate amounts of fluoride.

Stability - 2-100 ppb levels stable for months in 1% HNO3 / LDPE container. 1-10,000 ppm solutions chemically stable for years in 2-5% HNO3 / LDPE container.
