4.0 TRACEABILITY TO NIST

- This product is traceable to NIST via an unbroken chain of comparisons. The uncertainties for each certified value are reported, taking into account the SRM/RM uncertainty error and the measurement, weighing and volume dilution errors. In rare cases where no NIST SRM/RM are available, the term 'in-house std.' is specified.

4.1 Thermometer Calibration

- All thermometers are NIST traceable through thermometers that are calibrated by an accredited calibration laboratory.

4.2 Balance Calibration

- All analytical balances are calibrated by an accredited calibration laboratory and procedure. The weights used for testing are annually compared to master weights and are traceable to NIST.

4.3 Glassware Calibration

- An in-house procedure is used to calibrate all Class A glassware used in the manufacturing and quality control of CRM/RMs.

5.0 TRACE METALLIC IMPURITIES (TMI) DETERMINED BY ICP-MS AND ICP-OES (µg/mL)

CRM/RMs are tested for trace metallic impurities by Axial ICP-OES and ICP-MS. The result from the most sensitive method for each element, is reported below. Solutions tested by ICP-MS were analyzed in an ULPA-Filtered Clean Room. An ULPA-Filter is 99.9985% efficient for the removal of particles down to $0.3 \, \mu m$.

7.0 INSTRUCTIONS FOR THE CORRECT USE OF THIS REFERENCE MATERIAL

7.1 Storage and Handling Recommendations

- Store between approximately 4° 30° C while in sealed TCT bag.
- While stored in the sealed TCT bag, transpiration of this CRM/RM is negligible. After opening the sealed TCT bag transpiration of the CRM/RM will occur, resulting in a gradual increase in the analyte concentration(s). It is the responsibility of the user to account for this effect. When the bottle is weighed both before and after being placed in storage, the mass difference observed will be a measure of transpiration mass loss.
- After opening the sealed TCT bag, keep cap tightly sealed when not in use and store between 4° 24° C to minimize the effects of transpiration. Use at $20^{\circ} \pm 4^{\circ}$ C to minimize volumetric dilution error when using the reported density. Do not pipette from the container. Do not return removed aliquots to container.

Atomic Weight; Valence; Coordination Number; Chemical Form in Solution - 74.92; +5; 6; H3AsO4 Chemical Compatibility - Arsenic has no cationic chemistry. It is soluble in HCl, HNO3,H3PO4, H2SO4 and HF aqueous matrices water and NH4OH. It is stable with most inorganic anions (forms arsenate when boiled with chromate) but many cationic metals form the insoluble arsenates under pH neutral conditions. When fluorinated and / or under acidic conditions arsenate formation is typically not a problem at moderate to low concentrations.

Stability - 2-100 ppb levels stable for months alone or mixed with other elements at equivalent levels in 1% HNO3 / LDPE container.

As5 Containing Samples (Preparation and Solution) - Metal (soluble in 1:1 H2O / HNO3); Oxides (the oxide exists in crystalline and amorphous forms where the amorphic form is more water soluble. The oxides typically dissolve in dilute acidic solutions when boiled); Minerals (one gram of powered sample is fused in a Ni crucible with 10 grams of a 1:1 mix of K2CO3 and KNO3 and the melt extracted with hot water); Organic Matrices (0.2 to 0.5 grams of sample are fused with 15 grams of a 1:1 Na2CO3 / Na2O2 mix in a Ni crucible. The fuseate is extracted with water and acidified with HNO3).

11.1 Certification Issue Date

December 19, 2022

- The certification is valid within the measurement uncertainty specified provided the CRM/RM is stored and handled in accordance with instructions given in Sec 7.1. This certification is nullified if instructions in Sec 7.1 are not followed or if the CRM/RM is damaged, contaminated, or otherwise modified.

11.2 Lot Expiration Date

- December 19, 2027
- The date after which this CRM/RM should not be used.
- The lot expiration date reflects the period of time that the stability of a CRM/RM can be supported by long term stability studies conducted on properly stored and handled CRM/RMs. Lot expiration is limited primarily by transpiration (loss of water from the solution) and infrequently by chemical stability.

11.3 Period of Validity

Sealed TCT Bag Open Date:	

- This CRM/RM should not be used longer than one year (or six months in the case of a 30 mL bottle) from the date of opening the aluminized bag or after the date given in Sec. 11.2, whichever comes first.
