### 4.0 TRACEABILITY TO NIST

- This product is traceable to NIST via an unbroken chain of comparisons. #### 4.2 Balance Calibration

- All analytical balances are calibrated by an accredited calibration laboratory and procedure. The weights used for testing are annually compared to master weights and are traceable to NIST.
