# 4.0 TRACEABILITY TO NIST

- This product is traceable to NIST via an unbroken chain of comparisons. # 4.1 Thermometer Calibration

- All analytical balances are calibrated by an accredited calibration laboratory and procedure. The weights used for testing are annually compared to master weights and are traceable to NIST.

## 4.3 Glassware Calibration


- An in-house procedure is used to calibrate all Class A glassware used in the manufacturing and quality control of CRM/RMs.
