- The Calculated Value is a value calculated from the weight of a starting material that has been certified directly vs. a National Institute of Standards and Technology (NIST) SRM/RM. See Sec 4.2 for balance traceability.

- This product is traceable to NIST via an unbroken chain of comparisons. In rare cases where no NIST SRM/RM are available, the term 'in-house std.' is specified.

# 4.1 Thermometer Calibration

- All thermometers are NIST traceable through thermometers that are calibrated by an accredited calibration laboratory.

## 4.2 Balance Calibration

- All analytical balances are calibrated by an accredited calibration laboratory and procedure. The weights used for testing are annually compared to master weights and are traceable to NIST.

## 4.3 Glassware Calibration


- An in-house procedure is used to calibrate all Class A glassware used in the manufacturing and quality control of CRM/RMs.
